Monday, April 6, 2020

Due to the State Public Health Emergency Declaration regarding COVID-19, this meeting was conducted electronically pursuant to Iowa Code 21.8 and the Proclamation of Governor Kim Reynolds dated March 19, 2020.

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, via teleconference on Monday, April 6, 2020 at 5:30 PM. Council members present via teleconference were: R. Hardman, G. Hudson, M. McKinney, K. Trevillyan, and R. Trimble.

On Item 3. Council/Manager/Other Entities Reports:

Council member Hardman reported the Library Board of Trustees and Human Rights Commission both have meetings scheduled to be held via teleconference later this week. She also reported she attended a meeting of the Development and Planning Subcommittee, where discussion was held on handicap accessibility.

Council member Trimble reported Des Moines Area Regional Transit Authority (DART) has experienced a significant decrease in ridership due to the COVID-19 pandemic and is implementing a plan to reduce service.

Council member Hudson reported the Greater Des Moines Convention and Visitors Bureau is starting its budget process and he has been appointed to the budget committee.

City Manager Tom Hadden reported that City offices are closed due to the COVID-19 pandemic, but staff are still working behind the scenes, with a majority working remotely from home.

Council member Trevillyan noted the lower level of this development project will be leased as retail space, and he inquired how the minimum jobs requirement would be applied to this situation.

Katie Hernandez, Business Development Coordinator, responded the developer is guaranteeing the jobs on behalf of the tenant that will be locating in the building. She noted if that tenant were to leave, the property owner would be allowed to find a new tenant, and the minimum jobs

requirement would still apply to the new tenant. She also noted the agreement has a withholding provision if the property owner should fail to comply with the minimum jobs requirement.

Council member Trevillyan suggested the agreement should specify the length of time granted to the property owner to find a new tenant if the initial tenant should leave.

Mayor Gaer stated the property owner would have an incentive to find a new tenant as soon as possible, because if they don't have a tenant, then they would not be in compliance with the minimum jobs requirement, therefore they would not be receiving payment.

Council member McKinney noted the Development and Planning Subcommittee has been discussing a proposed ordinance amendment regarding handicap accessibility, and he inquired if this development project will include an elevator for the upper story housing units.

Lynne Twedt, Development Services Director, responded this development project would be subject to the current ordinance, which requires an elevator for these upper story housing units.

He stated ATO Builders has already been awarded contracts for previous phases of this project, so the continuity would be helpful. He stated it is important to get this project started as soon as possible so it can be completed during the 2020 construction season, and he noted the low bid for the site improvements phase of this project was \$1 million under the estimate.

Council member McKinney inquired about the status of the long-term care facilities in our city and how they are addressing to the COVID-19 pandemic.

Fire/EMS Chief Craig Leu responded staff has met with the managers of those facilities in West Des Moines, and they have indicated they have sufficient supplies and are well prepared.
